

REGULATIONS OF SKI RESORT
"SKRZYCZNE COS" IN SZCZYRK

GENERAL PROVISIONS

1. Before entering the Skrzyczne COS Ski Resort in Szczyrk (hereinafter: the Resort), please read these Regulations, and entering the Resort's premises is tantamount to accepting these Regulations.
2. The center is, among others, an organized ski area within the meaning of the Act of August 18, 2011 on safety and rescue in the mountains and organized ski areas (hereinafter: the Act).
3. Central Sports Center - Olympic Preparation Center in Szczyrk (Budget Management Institution) Plażowa 8 street, 43-370 Szczyrk manages the Resort, including: an organized ski area within the meaning of the above-mentioned Acts (hereinafter: Manager).
4. The Regulations specify the rules applicable to those using the Center, including the method of using ski slopes, cable cars and ski lifts in the Center.
5. The Center's facilities and equipment may only be used during their opening hours. Opening hours may change and are announced on an ongoing basis on the notice board and website <http://www.skrzyczne.cos.pl/>.
6. It is prohibited to:
 - a) bring items that pose a threat to safety, including the safety of skiing,
 - b) leave and throw away waste outside designated places,
 - c) bring animals into the premises of the Center without obtaining the consent of the Manager,
 - d) drink alcohol and smoking cigarettes in places other than those designated by the Manager, subject to the provisions of point 11 of the Regulations.
 - e) use routes not designated by the Administrator and routes not illuminated after dark.
7. Users of the Center should regularly read the Management's announcements, in particular those containing:
 - a) overview maps of organized ski areas, indicating the route, difficulty, length and marking of the downhill and cross-country ski trails and ski slopes available for use, as well as places that provide first aid;
 - b) information about possible closures of certain downhill and cross-country ski trails, ski slopes or their sections;
 - c) information about ski conditions, including in particular snow conditions, route preparation status, temperature, wind speed, visibility;
 - d) information promoting the rules of safe skiing and snowboarding;
 - e) methods of notifying about accidents, including telephone numbers of local ski rescue services and emergency numbers.
8. It is prohibited to enter the premises of the Center with motor vehicles outside the designated areas, provided that this does not apply to, among others: managing body, entities authorized to perform mountain rescue, ski rescuers and services performing tasks in the field of safety, public order and nature protection. People present on the premises of the Center are then obliged to facilitate the passage of the vehicle, in particular by immediately giving way.

SKIING AND SNOWBOARDING

9. People practicing skiing or snowboarding at the Resort are obliged to exercise due care in order to protect their own life and health and that of other people, and in particular:

- a) familiarise yourself with the rules of using the Center and comply with them;
- b) complying with mandatory and prohibited signs placed by the Manager, in particular to use only designated routes (the boundaries of ski routes may be marked by nets, flags and other signs);
- c) descend at a speed adapted to your skills and the degree of difficulty and condition of the route, weather conditions and traffic intensity;
- d) use of technically efficient ski and snowboard equipment appropriate to the type of activity undertaken, in accordance with its intended purpose and rules of use;
- e) immediately inform ski rescuers about an accident or missing person and about other extraordinary events that may affect the safety of people (the person involved in the collision should provide his/her personal data);
- f) familiarising yourself with and applying the Code of Conduct for Skiers and Snowboarders (the so-called FIS Skier Decalogue).
- g) A person practicing downhill skiing or snowboarding under the age of 16 is obliged to use a protective helmet designed for this purpose while riding.

10. It is prohibited to ski or snowboard under the influence of alcohol or drugs. The Manager or a person authorised by him may refuse entry or order to leave the Center to a person whose behavior clearly indicates that he or she is intoxicated or under the influence of a narcotic drug.

USE OF CABLEWAYS AND SKI LIFTS

11. People using cable cars and ski lifts are obliged to:

- a) comply with the rules for using these devices, in particular information specifying the maximum number of people using the device (e.g. chair, gondola) and how to arrange skis, poles, snowboards, etc. - this information may also result from pictorial instructions (so-called pictograms),
- b) get on and off only at designated places,
- c) use safety devices, e.g. handrails, belts, fasteners, locks,
- d) secure loose clothing items (e.g. scarves, belts, tapes) against getting entangled in devices,
- e) follow the instructions of the Manager or persons authorised by him.

12. While riding a cable car or ski lift, any behavior that may cause danger is prohibited, including leaning out, swinging, opening safety devices, and throwing any objects.

13. In the case of a stoppage in the operation of cable cars and ski lifts, remain calm and wait for traffic to resume or for clear instructions from the Manager or persons authorised by him.

FINAL PROVISIONS

14. Violation of the provisions of these Regulations, in particular despite prior warning, may result in, among others: refusal to continue providing services regardless of the validity of the pass or ticket, as well as liability for damages on general principles, especially in cases of causing difficulties in the normal operation of the Center.

15. Organising, conducting and advertising ski training at the Center without the written consent of the Manager is prohibited. In the event of violation of this Prohibition, the Manager is entitled to charge a contractual penalty of PLN 10,000. Despite the above, the Manager is entitled to claim compensation from the entity violating the prohibition on general terms.

16. Whenever the Regulations refer to people authorised by the Manager, it is indicated that these people may be employees of the Resort or ski rescuers, but they are not obliged to have a written authorisation from the Manager.

17. The following regulations constitute an integral part of these Regulations:

- a) Code of conduct for skiers and snowboarders (so-called FIS Skier's Decalogue).
- b) Regulations on the use of contactless tickets and passes for COS-OPO lift devices in Szczyrk and SON S.A.

19. Should there be cases not regulated in the Regulations, the Manager is authorised to resolve existing matters on an ongoing basis.

20. These regulations do not prejudice the rights and obligations arising from mandatory provisions.
